WHO Should Attend: Agency trainers and officers wanting to expand their and their agencies ability with static vehicle encounters and armed occupants. The curriculum strives to offer training promoting safe encounters.

Attendees are responsible for their own travel, accommodations, and must bring personal protective gear (body armor, hearing and eye protection) and weapons (rifle & handgun) with 200 rounds of ammunition for each weapon. *Lunch is provided by WCPOA on training days.*

 - Developing techniques over weapons mods.
 - Ambidextrous gun handling skills
- 1:00p.m.–2:00p.m. **Lunch at the range** (*Provided by WCPOA*)
- 2:00p.m.–5:00p.m. *Handgun, shotgun, and rifle vs. automotive structures*
- Understanding the dynamics of bullet influence upon metal, plastic and glass. Shooting through vehicular glass and doors utilizing concealment and cover demonstrations and expectations.
